Mets, Schiro & McGovern, LLP 555 U.S. Hwy. 1 South, Suite 240 Iselin, New Jersey 08830 Effective October 16, 2020, the Borough of Roselle Park and PBA Local 27 (collectively, the "Parties") agree that Article 8, "Salaries," Section J., "Corporal Assignment" of the prevailing collective bargaining agreement be amended as follows:

1. Paragraph 3 of Section J. within Article 8 shall hereafter read:

"The assignment of Corporal is not intended to circumvent filling vacancies in the Sergeant rank. If a member is assigned to the position of Corporal by the Chief of Police and that Corporal is assigned to a shift where there is an absence of a Patrol Sergeant for more than (30) consecutive working days the member shall be entitled to the difference in pay from Corporal to Sergeant for any days worked after the thirtieth (30th) working day. This compensation shall not be paid retroactively to the prior thirty (30) days. Any time off scheduled in accordance with this contract during the thirty (30) work day period shall be honored and shall not affect the Corporal's status of attaining the thirty (30) working days. Use of any sick time or time off not in accordance with this contract shall reset the thirty (30) work day time period. Once the thirty (30) working days have been achieved and the Corporal takes any time off that they are scheduled to work as the "supervisor" they shall not be compensated the difference between Corporal and Sergeants pay for that/those day(s), but the Corporal shall be entitled to the difference upon resuming their normal shift if their Patrol Sergeant remains absent."

2. Paragraph 9 of Section J. within Article 8 shall hereafter read:

"For the purposes of vacation selection as set forth in Article 15, all vacations will continue to be picked by seniority, based on the date of hire. However, a member assigned to the position of Corporal shall be granted three (3) additional vacation picks when compared to a member of equal rank and seniority."
