Box 295 Edison, New Jersey 08818 Effective January 1, 2022, the Borough of Roselle Park and the Roselle Park Clerical Group (collectively, the "Parties") agree that Article 27, "Health Insurance" of the prevailing collective bargaining agreement be amended as follows:

### 1. Section A.2. within Article 27 shall hereafter read:

"At the time of retirement, the Borough shall pay the full cost of the premium of the policy in effect at the time of retirement, less the retiree's contribution made pursuant to the contribution limits set forth in P.L. 2011, c. 78, for hospital and major medical insurance of unit members who have accumulated at least fifteen (15) years of service with the Borough of Roselle Park and have attained the age of sixty-two (62). This benefit shall be available upon proof that said retiree is not receiving similar benefits from another employer, a former employer, or another source on a non-contribution basis."

## 2. Section C.2. within Article 27 shall hereafter read:

"At the time of retirement, the Borough shall pay the full cost of the premium of the policy in effect at the time of retirement, less the retiree's contribution made pursuant to the contribution limits set forth in P.L. 2011, c. 78, for the drug prescription program of unit members who have accumulated at least fifteen (15) years of service with the Borough of Roselle Park and have attained the age of sixty-two (62). This benefit shall be available upon proof that said retiree is not receiving similar benefits from another employer, a former employer, or another source on a non-contribution basis."
