**RESOLUTION OF THE MUNICIPAL LAND USE BOARD



NOW, THEREFORE, BE IT RESOLVED by the Municipal Land Use Board of the Borough of Roselle Park, County of Union, State of New Jersey that the firm Weiner Law Group, LLP of One River Centre, 331 Newman Springs Road, Building 1, Suite 136, Red Bank, New Jersey 07701 be and is hereby appointed to the position of Municipal Land Use Board Attorney of the Borough effective January 16, 2023 for a term set to expire December 31, 2023 pursuant to a Fair and Open process under *N.J.S.A. 19:44A-20.4 et seq.*; and,


BE IT FURTHER RESOLVED that a professional service agreement is hereby authorized so as to include compensation in the amount of \$125.00 per hour with a maximum contract amount not to exceed ten-thousand dollars and zero cents (\$10,000.00).
