**RESOLUTION OF THE MUNICIPAL LAND USE BOARD  
OF THE BOROUGH OF ROSELLE PARK, NEW JERSEY**

**RECOGNIZING THE BOROUGH ENGINEER,  
COLLIERS ENGINEERING & DESIGN, INC., AS THE  
2025 BOARD ENGINEER**

**WHEREAS**, the firm Colliers Engineering & Design, Inc. was responsive to the Request for Proposals (hereinafter, "RFP") due November 13, 2024 at 11:00 a.m. for the position of Borough Engineer; and,

**WHEREAS**, Mayor Joseph Signorello III filed his appointment of Colliers Engineering & Design, Inc. as Borough Engineer of the Borough of Roselle Park (hereinafter, the "Borough") for the years 2025, 2026, and 2027; and,

**WHEREAS**, the Mayor's appointment of Colliers Engineering & Design, Inc. as Borough Engineer was subsequently confirmed by the Borough Council through their passage of Resolution No. 21-25; and,

**WHEREAS**, the professional service agreement between the Borough and Colliers Engineering & Design, Inc. for services as Borough Engineer stipulates and otherwise includes provisions such that said firm shall serve as Board Engineer for the Municipal Land Use Board of the Borough concurrently with their service as Borough Engineer; and,


**WHEREAS**, the foregoing Resolution has been sequenced for consideration in an effort to formally recognize the contractual designation and assignment of Colliers Engineering & Design, Inc. as 2025 Board Engineer consistent with the response submitted by said firm.


**NOW, THEREFORE, BE IT RESOLVED** by the Municipal Land Use Board of the Borough of Roselle Park, County of Union, State of New Jersey that the firm Colliers Engineering & Design, Inc. of 331 Newman Springs Road, Suite 203, Red Bank, New Jersey 07701 be and is hereby recognized as Board Engineer of the Borough's Municipal Land Use Board for calendar year 2025 pursuant to a Fair and Open process under *N.J.S.A. 19:44A-20.4 et seq.*; and,

**BE IT FURTHER RESOLVED** that the promulgation of a professional service agreement, and the certification of funds associated therewith, shall be made by Resolution of the governing body of the Borough of Roselle Park within their judgement, by formal Resolution, and consistent with the response submitted by said firm.
