**RESOLUTION OF THE MUNICIPAL LAND USE BOARD
OF THE BOROUGH OF ROSELLE PARK, NEW JERSEY**

**ADOPTING REGULAR MEETINGS DATES

WHEREAS, pursuant to Chapter 231, Laws of 1975, known as the Open Public Meetings Act, all meetings of all public bodies wherein formal action, decision or discussion relating to the public business may take place, are required to be publicly announced and scheduled, with adequate posting and advance notice of the time, date, location, and to the extent known, the purpose or agenda of each such meeting.

July 21, 2025



Appropriate officials are hereby authorized and directed to (1) post and maintain a copy hereof official bulletin board reserved for public notices; (2) file a copy of the foregoing Resolution with the Borough Clerk; (3) transmit copies to the local official newspapers circulating in Roselle Park, New Jersey; and,
4. Do anything necessary hereafter to comply with said statute to the end that adequate public notice of all such public meetings, pursuant to such statute be given according to law.


